### **CURATED GROUPS**

Often, solutions that work in one industry can be applied to another. Members are placed in groups based on company size.

#### **GROUP MEETINGS**

Typically, the groups meet virtually for 8 of the 12 meetings during the year. Each quarter, the groups meet in person in a central location that's a quick flight for most Members (Dallas or Chicago, for example). A Member with an office located in the host city may elect to provide their conference room for the meeting. Alternatively, Apex will arrange suitable meeting space.

#### **ISSUE PROCESSING**

At Apex, we are focused on helping our Members achieve better results. Each half-day mastermind session will include a minimum of three spotlights in which a Member presents a specific issue or opportunity they would like to discuss. Fellow Members then provide input based on their experience and knowledge.

#### **PROFESSIONAL MODERATORS**

Meetings are led by our highly skilled moderators and formatted to create maximum impact. Group moderators are Highrise employees trained to engage Members of the group in relevant discussions and ask non-leading questions that encourage valuable insight and advice.

### **SMALL-GROUP SIZE**
